

Reported information on large combustion plants under the Energy Community Treaty

This dataset contains the location and administrative data for Large Combustion Plants in the Energy Community member countries, as well as more detailed data on energy input and emissions to air. These data are reported to the EEA under the Energy Community Treaty. Warning: Reporting countries have only recently started to report and it is expected that data quality will increase as experience in reporting consolidates.
